






5. TERMS AND CONDITIONS FORMING PART OF THIS APPLICATION:

The terms and conditions given below shall form part of this Application and shall be binding on the Applicant(s):

- A. The Applicant(s) have clearly understood that this Application does not constitute an agreement and the applicant will not be appointed as a sole selling agent.
- B. The Applicant (s) scope of work shall include the following:-
 - I. Get the prospective clients for all the ongoing projects and future projects.
 - II. Conduct site visit of project selected by client and assist them to finalize the flat.
 - III. Co-ordinate with our sales executive and the client.
 - IV. Follow up with client for feedback.
 - V. Facilitate closing of the deal with client.
 - VI. Provide all the details required by the client and our sales executive.
 - VII. Facilitate paperwork, documentation and registration as per the draft provided by us.
 - VIII. Facilitate payment as per installments stated in the agreement to be signed between the clients and us.
 - IX. Facilitate possession of the Flat.
 - X. Facilitate cancellation of the deal in the event of default on the part of the client to complete the transaction.
 - XI. To promote the projects
- C. The remuneration to be paid to the Applicant shall be 2 % of the total consideration of the deal excluding tax if any applicable. It is further provided that the remuneration payable to the Applicant (s) shall be
 - I. @ of 1.5 % for 1st 5 flats or value 10 Crores whichever is higher.
 - II. Once the target is achieved the remuneration shall be increased to 2 % and the difference of past sale (i.e., 1.5%-2 %) shall be reimbursed by us.
- D. The brokerage shall be paid in the following manner:-
 - I. 25% of the total remuneration due and payable to be paid on booking of flats.
 - II. 75% of the total remuneration due and payable to be paid at the time of execution of the agreement in favour of the Flat Purchasers.
- E. The Applicant(s) are aware that in the event the deal is cancelled then the applicant shall refund the amount if any paid to them.
- F. The Applicant (s) is aware that the lead brought by the Applicant (s) shall remain his lead for the period of 3 months and after expiry of the period of 3 months the Applicant (s) shall not claim any brokerage from the Developers in the event the deal goes through.
- G. The Applicant (s) shall not misguide the lead on the Company information/project detail for sale purpose. Any misrepresentation will be his responsibility.
- H. The Applicant(s) shall not indulge in any wrongful act, deeds, matters and things either with the sales executive or with the client.
- I. The Applicant (s) shall not bad influence the client.

- $K. \quad \text{ All the payments will be done in cheque only in the name of the Applicant (s)}.$
- L. The Applicant (s) shall keep the details, information, and every information known to him/them in respect of the company the project as confidential information and not share the same with any third party. The breach of this term shall be construed as a serious breach and the contract shall stand terminated with them and the consequences of breach of trust shall follow.
- M. All payments due and payable in accordance with the terms hereof shall be due and payable at Mumbai only.
- N. The Applicant (s) has fully read the terms and conditions herein above mentioned and agree (s) to abide by the same without any demurs or protests.
- O. The Applicant(s) shall sign all the pages of this Application in token of his/their acceptance of the same.
- P. Booking of a unit/flat through a Channel Partner will be recognized only if:
 - I. An authorized representative of the Channel Partner accompanies the client during their 1st visit at sales office.
 - II. At the time of 'welcome call' made by Modispaces Real Estate Pvt. Ltd, customer should agree & confirm the Channel Partner's intermediary role.
 - III. Channel Partner must ensure that the customer acknowledges in writing the channel partner's name & intermediary role on the Booking Form.
- 2. TDS will be deducted as per applicable rules and regulations, certificate for the same will be provided.

Commission/brokerage can be claimed by the Channel Partner through an invoice duly signed and stamped by the Authorized Signatories which is commensurate with the Channel Partner Registration Form.
